## **Lesson Guide and Applicable Michigan Social Studies Standards and Content Expectations for 2nd and 3rd Grades**

### ***DETROIT, MI: HENRY FORD'S PIQUETTE PLANT (1906)***

This *TimeShift* episode takes students on a virtual field trip to the Milwaukee Junction Neighborhood of Detroit, Michigan. The focus of this lesson is the birthplace of the automobile: Henry Ford's Piquette Plant, which is on the National Register of Historic Places.

The Piquette Avenue Plant was used by Henry Ford, and his newly formed Ford Motor Company, to develop and build dependable automobiles. Ford and his team of experts came up with unique ideas to build a quality automobile that Americans could afford to purchase. Ford developed the assembly line to simplify and speed up car production. It was so successful that Ford had to build a larger factory in Highland Park in 1913 to keep up with production.

Wanting reliable workers, in 1914, he began paying employees \$5 per day. That was more than double the typical pay of the time. Inclusive in his hiring practices, Ford insisted his company employed people from many diverse groups.

As a result of Ford's innovations in designing and producing automobiles, over 15 million Model T's were produced between 1908 and 1927. Consumers benefited, as the purchase price of a Model T dropped from \$700 in 1910 to \$350 in 1917.

Exemplifying the efforts of Henry Ford and his Ford Motor Company, the Model T was recognized in 1999 as the "*Car of the Century*" by the Global Automotive Elections Foundation. Today, the Piquette Avenue Plant is a museum that provides a unique experience of early automotive history, Detroit innovation, and the birth of the Motor City.
